



## DIY Big Freeze Slider: Trade Promotion Lottery Terms and conditions

### 1. Promoter

The promoter is FightMND Ltd (ABN: 62 740 350 704) of 570 Swan Street, Burnley VIC 3121 ("Promoter").

### 2. Eligibility

Entry is open to residents of Australia aged 18 years or over that register for a DIY Big Freeze fundraiser. Employees of the Promoter and their immediate families are not eligible to enter.

### 3. Promotion Period

The promotion commences at 7am on 11 March 2026 and closes at 5pm on 11 May 2026 ("Promotion Period").

### 4. How to Enter

To enter, participants must register during the Promotion Period to host a DIY Big Freeze fundraiser event via the Promoter's website at [www.fightmnd.org.au](http://www.fightmnd.org.au). Entry into the prize draw is free. No purchase, donation or active fundraising is required to enter the draw.

### 5. Prize

The prize includes: An exclusive opportunity for one person to slide down the Big Freeze slide at the MCG on Monday 8 June 2026, two tickets to the Big Freeze Game at the MCG on Monday 8 June 2026, two nights accommodation in a standard room for two people (Sunday 8 June and Monday 9 June 2026) at the Pullman Hotel Melbourne, a \$2000 travel voucher and a merchandise prize pack. If the prize is not claimed within 7 days of notification, a redraw will occur at the same location on 19 May 2026 at 10am.
